*Welcome to Mary of Lourdes’ Early Bird & Nighthawk Programs!*

This program helps accommodate our MOL families who need help with before and after school child care.

Details about the programs:

- The programs will be available on days when school is in session.
- Early Bird operates from 6:45 – 8:00 a.m. each school day. Nighthawks will operate from 3:00 - 5:30 p.m. each school day.
- The program is held at the elementary school. Early Birds will meet in the classroom next to the Art Room. NightHawks will meet in the gym. Enter the building through door #2 for EB drop off and NH pick up.
- If school is canceled or delayed, the program will be canceled. If there is a scheduled early release, Nighthawks will not be in operation. If school closes early due to inclement weather, parents need to make arrangements to pick up their child/ren as soon as possible so our staff can get home safely.
- The **Early Bird cost** is \$4.00 per child/per day for the first child and \$2.00 for each additional child in the family per day.
- The **Nighthawks cost** is \$3.00 per child/per day if the child is picked up by 4:00 p.m. The cost for a child picked up after 4:00 p.m. will be \$6.00.
- K-8 students are welcome to come occasionally or on a daily basis.
- We will bill families on a monthly basis for this service (on the 10th of each month on your tuition statement).
- **Parents are REQUIRED to sign their child/ren in each morning for Early Birds,** in the classroom, when they arrive.
- Children may bring a snack from home to eat and/or drink while they are there.
